

King Avenue Elementary School Parent Involvement Policy

GENERAL EXPECTATIONS

*According to the Elementary and Secondary Education Act (ESEA), every district and every school using Title I funds must develop jointly with parents of children participating in Title I programs a written parent involvement policy.

King Avenue Elementary School agrees to implement the following statutory requirements:

King Avenue Elementary School will implement required school Parental Involvement Policy components as follows:

- The school will take the following actions to involve parents in the joint development and joint agreement of its School Parental Involvement Policy and its school-wide plan in an organized, ongoing, and timely way under section 1118(b) of ESEA:
 - Include a review and adoption of the Parental Involvement Policy as an agenda item for a School Site Council meeting and ELAC meetings.

- The school will make available to parents a description and explanation of the California State Standards, the forms of academic assessment used to measure student progress, and the proficiency levels students are expected to meet:
 - King Avenue teachers share assessment processes and results during goal setting conferences at the beginning of the year as well as parent conferences, and report cards.
 - King Avenue teachers share assessment processes and results during parent conferences and at the time of the first grading period.
- The school will provide parents opportunities for regular meetings to formulate suggestions and to participate in decisions relating to the education of their children. King Avenue will address suggestions in a timely manner:
 - Parents are invited to School Site Council and ELAC meetings and to join the parent club, KAPTO, and participate in its monthly meetings.
 - Parents meet with King Avenue School teachers for conferences during parent/teacher conference week.
 - Parents meet with King Avenue School teachers in the form of parent/teacher conferences and SST's regarding students who are at risk on a regular basis.
 - Parents may make appointments to speak with school personnel do discuss their child's program at any time during the school year.
- The school will submit to the district any parent comments if the school wide plan under section (1114)(b)(2) is not satisfactory to parents of King Avenue School students:
 - The members of the King Avenue School community are made aware of the Williams Uniform Complaint Procedures in the following ways:
 - District Handbook
 - Posters in classrooms and hallways

RESPONSIBILITIES FOR HIGH STUDENT ACADEMIC ACHIEVEMENT

- King Avenue School will build the school's and parents' capacity for strong parental involvement, in order to ensure effective involvement in working to improve student academic achievement, through the following activities specifically described below:
 - Parents are encouraged to participate in the King Avenue Parent Teacher Organization (KAPTO).
 - Parents are encouraged to volunteer in student classrooms.
 - Teachers keep an open line of communication with parents through a variety of means, such as: email, phone, and conferences.
- King Avenue School will, with the assistance of the district office, provide assistance to parents of King Avenue School students in understanding topics such as the following:

 - Monitoring their child's progress
 - Working with educators

 - Parent/Teacher Conferences

- King Avenue School will, with the assistance of the Yuba City Unified School District, and parents, educate its teachers, pupil services personnel, principals, and other staff about how to interact with parents as equal partners.
